- Operational Updates
  - CVP: Lewiston releases at 3,800 cfs, heading towards a long ramp down through the end of June. Whiskeytown releases at 225 cfs, cut down from 250 cfs on 4/22. Keswick release is 6,000 cfs, next pulse Tuesday 4/29 to ramp back up to 10,000 cfs. Nimbus release is at 5,350 cfs with cuts on 4/28, ongoing discussion for a spring pulse. Stanislaus is at 1,000 cfs with a Stepped Release Plan spring pulse. Jones Pumping Plant is exporting 900 cfs, proportional share of Vernalis 1:1 – 3 day average – planning an increase to 1,800 cfs on 4/25 if conditions are amenable. Federal share of San Luis Reservoir 842 TAF. Delta Cross Channel Gates remain closed through late May unless water quality issue.
  - SWP: Feather River (Oroville-Thermalito Complex) releases are decreasing today (4/23) down from 4,000 cfs to 3,000 cfs, with additional decreases coming over the next few days. Clifton Court is exporting 600 cfs and holding. State share of San Luis Reservoir 921 TAF.
