- Operational Updates
  - CVP: Lewiston Dam releases at 800 cfs within ROD (long ramp down through end of June). Whiskeytown Dam releases at 350 cfs (dropping down from 500 cfs), moving to 125 cfs between 6/18 - 6/26. Keswick Dam releases at 12,000 cfs, increasing to 13,000 cfs on 6/19 for downstream demands. Nimbus Dam releases at 2,500 cfs. Goodwin Dam releases at 1500 cfs (6/19 to 1,000 cfs, 6/20 to 700 cfs, 6/23 to 1,000 cfs). Jones Pumping Plant exporting 3,200 cfs, OMRI of -5,000 cfs and D1641 controlling. Federal share of San Luis is 529 TAF. Delta Cross Channel Gates are currently closed and planned to open Friday 6/20 and close Monday 6/23.
  - SWP: Feather River (Oroville-Thermalito Complex) releases are at 4,500 cfs (holding). Clifton Court Forebay is exporting 1,700 cfs, expected to drop gradually to manage salinity. (An herbicide treatment is planned for 6/30; Clifton Court Forebay Gates will be closed for 24 hours before and after the herbicide application.) State share of San Luis Reservoir is 595 TAF.

  - Update: Warming trend with dry conditions. A cooling trend later in the week.
