- Operational Updates
  - CVP: Lewiston Dam releases at 450 cfs (base flow, reductions 10/16 to 300 cfs), Whiskeytown Dam releases at 225 cfs (seasonal base flow), Keswick Dam releases at 7,200 cfs, Nimbus Dam releases at 1,000 cfs. Goodwin Dam releases at 750 cfs (Fall Pulse flow begin 10/15), Jones Pumping Plant at 1,800 cfs (D-1641 controlling, CVP maintenance activities between 10/6-10/25 may expect changes in cfs), Federal share of San Luis is 250 TAF. Delta Cross Channel is open (Ongoing modeling evaluations).
  - SWP: Feather River (Oroville-Thermalito Complex) releases at 2,450 cfs. Clifton Court Forebay is exporting 2,000 cfs (monitoring water quality). State share of San Luis Reservoir is 838 TAF.
- Hydrology Update
  - Rain passed through the region and finished up this morning. Expecting a sunny and dry stretch for the next 10 days.
