- SMT ITP Risk Assessment Summary – No Risk Assessments Until December
- Operational Updates
  - CVP: Trinity River release is 300 cfs. Clear Creek (Whiskeytown Dam) release is at 200 cfs. Sacramento River (Keswick) release is 5,800 cfs and will be going down to minimum flow of 4,000 by November 17 and for the next three months. American River (Nimbus) release is 2,000 cfs. Stanislaus River (Goodwin) release is 250 cfs today and decreasing to 200 cfs tomorrow for base winter flow. Reclamation's Delta export is currently 3 units and will be increasing to 4 units once repair work is completed. Federal share of San Luis Reservoir is 340 TAF. Delta Cross Channel Gates are open.
  - SWP: Feather River (Oroville-Thermalito Complex) releases are at 1,750 cfs today. Clifton Court Forebay exports are at 2,900 cfs. State share of San Luis Reservoir is 718 TAF.

  - Minor storm coming next week, otherwise and dry and relatively cool.

## Discussion Items

- Bypass Extension Discussion in the American River Group (ARG).
  - Reclamation: Upon the request of CDFW, Reclamation evaluated extending the power bypass and will continue the power bypass for another week, with reevaluation next week. CDFW said that water temperature was an issue; however, no specific target temperature was provided. Reclamation is seeking guidance from CDFW on what achievable water temperature they would like to see.
  - CDFW Response (by email on 11/7/2024): The temperature and dissolved oxygen targets should be 56 degrees F and 7 mg/L, respectively, at both Hazel Avenue and Nimbus to support in-river and hatchery egg incubation and survival. These targets were provided in the power bypass request to Reclamation from the Fisheries Agencies on September 30.
