Review Operations Outlook

- Clear Creek releases at Whiskeytown Dam are currently 225 cfs.
- Sacramento River releases at Keswick Dam are currently 4,000 cfs.
- Feather River releases at Oroville Dam are currently 2,450 cfs.
- American River releases at Nimbus Dam are 1,000 cfs.
- Stanislaus River releases at Goodwin Dam are 200 cfs.
- CCF exports are at 5,500 cfs.
 - Due to the weekend storm, runoff is increasing Delta outflows, and CCF exports are expected to remain near 5,500 cfs over the next couple of days.
- JPP exports are at 3,500 cfs.
- DCC gates are closed.

Additional Questions or Comments

- DWR noted that the gates for the Big Notch Project opened today for the first time and are set to pass up to 600 cfs. Current projections indicate a peak of about 120 cfs, with current flow around 50 cfs.

Review PA Assessment (Reclamation)

- Reclamation provided an update on winter-run Chinook salmon. Key points included:
 - Recent monitoring at Knights Landing recorded 187 winter-run and 76 spring-run Chinook salmon at the rotary screw traps to date.
 - The DCC gates remain closed, and recent rainfall is contributing to significant downstream migration.

Additional Questions or Comments

- Baykeeper asked whether an action assessment is being developed to prevent additional take, as current green sturgeon salvage is at six of the annual 14-fish limit.
 - An action item to follow up on this question was assigned to K&W and Reclamation, with a goal of following up at the next DMW meeting if not sooner.
