- Operational Updates
  - CVP: Lewiston Dam releases at 300 cfs (seasonal base flow), Whiskeytown Dam releases at 225 cfs (seasonal base flow), Keswick Dam releases at 4,000 cfs (seasonal base flow), Nimbus Dam releases at 1,000 cfs (seasonal base flow), Goodwin Dam releases at 200 cfs (seasonal base flow), Jones Pumping Plant at 3,500 cfs (maintenance limiting total export capabilities through 12-17), Federal share of San Luis is 329 TAF, Delta Cross Channel is closed (closed on 10/30).
  - SWP: Feather River (Oroville-Thermalito Complex) releases at 2,450 cfs. Clifton Court Forebay is exporting 5,500 cfs. State share of San Luis Reservoir is 803 TAF.
  - Hydrology Update:
    - Small system rolling through tonight (11/19) into tomorrow. Forecast is dry through end of November.
