- Operational Updates

- CVP: Trinity River release is 300 cfs. Clear Creek (Whiskeytown Dam) release is 200 cfs. Sacramento River (Keswick) release is 4,000 cfs. American River (Nimbus) release is 2,000 cfs. Stanislaus River (Goodwin) release is 200 cfs. Reclamation's Delta export is currently 5 units which is approximately 4,200 cfs. Federal share of San Luis Reservoir is 470 TAF. Delta Cross Channel Gates are closed and remain closed unless there are water quality issues.
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 1,750 cfs. Clifton Court Forebay exports are at 6,680 cfs. State share of San Luis Reservoir is 852 TAF.
- Hydrology Update (DWR and Reclamation)
  - Rain tonight and tomorrow and over the next 5 days.

## Upcoming Actions, Updates, and Discussion Items

- Salmon Monitoring Team (SaMT): The 2024 SWP ITP Condition of Approval COA 8.4.5 requires WOMT, with input from SaMT, to select three in-river releases of late fall-run Chinook salmon from Coleman National Fish Hatchery from November through February to use as yearling CHNSR surrogates. SaMT sent their proposal to WOMT. It was proposed that the second spring-run surrogate release group of late-fall-run Chinook salmon from Coleman National Fish Hatchery be released with the upcoming storm anticipated December 13-14. The agencies in WOMT discussed this proposal and were supportive of it or abstained from commenting on the proposal.
