- Operational Updates
 - CVP: Trinity River releases are at 330 cfs. Sacramento River (Keswick) releases will be at 5,000 cfs. Clear Creek is at 200 cfs. American River (Nimbus) releases are at 2,000 cfs. Reclamation's Delta pumping is at 3 units targeting 2,700 cfs. During maintenance, pumping will be at 1 unit for about 8 hours. Once maintenance is complete pumping will return to 3 units. Federal share of San Luis Reservoir is 716 TAF.
 - DO in Lake Natoma continues to improve. Monitoring below Folsom and Nimbus Dam is good coming in at >10 mg/L; within the channel, and away from the dam, DO ranged between 10-11 mg/L. There were some sub-parr readings within the upper reach, not sure what is causing this.
 - DCC gates were closed this morning (11/8/23) and will reopen Friday (11/10/23) to help with the Rio Vista Standard. This may need to occur again next week.
 - SWP: Feather River (Oroville-Thermalito Complex) releases are 1,750 cfs. Clifton Court Forebay exports are ranging between 2,000 and 3,000 cfs for the next few days. State share of San Luis Reservoir is at 582 TAF.
- Hydrology Update (DWR and Reclamation): A relatively large storm is forecasted for next week on 11/15 or 11/16.
