Review Operations Outlook (USBR, DWR)

- Due to the last storm series, facility volumes are/or are approaching encroaching in the flood management space, increasing the likelihood for elevated releases.
- Currently releasing 1,000 cfs downstream from Goodwin into the Stanislaus River with a change order to continue to manage the flood space due to the recent storm events, increasing releases to 1,500 cfs on Friday (1/26/2024).
- Freeport and Vernalis flows are in flux, increasing as a response to recent precipitation and runoff.
- A First Flush Action (Integrated Early Winter Pulse Protection) was triggered this week on January 21, 2024.
- JPP is currently targeting 3,600 cfs with a change order on Wednesday (1/24/2024) to reach 2,700 cfs, and decreasing through the week until the export rate reaches 1,800 cfs.
- Salinity conditions remain favorable in the Delta.
- Clifton Court exports are at 300 cfs today, progressively increasing later this week in response to increased Vernalis flows.

- SWP and CVP are coordinating exports to avoid exceeding the 14-day averaged -2,000 cfs OMR requirement.

Additional Questions or Comments

- Question: When do you expect to go to 2 units at JPP and is it sooner than this weekend?
 - Answer: We are not sure yet. It will likely be this weekend on Saturday or Sunday. However, it might be early next week.
- Question: When is the last day of First Flush Action scheduled for?
 - Answer: February 5th is the last day of the 14-day period required for First Flush.
 Note that the trigger mechanism of when the event can be triggered is for
 December through January, and does not apply in February. But once the action
 has been triggered, it needs to go for 14 days, meaning export reductions will
 continue into February.
