- Operational Updates
 - CVP: Trinity River release is at 2,700 cfs today and will slowly decrease through August 4. Sacramento River (Keswick) releases range from 8,700 cfs through Saturday. Clear Creek (Whiskeytown) release is 200 cfs. American River (Nimbus) release is 3,000 cfs reducing to 2,500 cfs. Stanislaus River (Goodwin) is currently releasing 2,000 cfs with the last pulse flow occurring this week.. Reclamation's Delta pumping is at 3,500 cfs (4 units). Federal share of San Luis Reservoir is 791 TAF.
 - SWP: Feather River (Oroville-Thermalito Complex) release is 2,100 cfs. Clifton Court Forebay exports are 600 cfs and projected to increase on 6/1. State share of San Luis Reservoir is at 450 TAF.
- Hydrology Update (DWR and Reclamation): Warm weather continues, with occasional gusty winds. Elevated fire concerns on Thursday. Onshore flow returns by the weekend.

Discussion Items

• Reclamation: We would like some direction on what OMRI we will be operating to over the next week. We would like to operate to -3500 and ramp up to -5000 OMRI next week.

- DWR: We support the adjustment to -3500 OMRI and reevaluating -5000 OMRI next week.
- NMFS: The proportion of Steelhead in the delta has decreased and other factors and lines of evidence indicate that risk to steelhead is decreasing. We don't object to -3500 and reevaluating next week. Winter-run are largely out of the Delta as well.
- DWR: The last salvaged winter run that was genetically confirmed was March 21st.
- CDFW: Operating to -3,500 OMRI and reevaluating next week is consistent with the advice from SaMT in the ITP risk assessment.
