Review Operations Outlook

- At Keswick Dam on the Sacramento River, releases are 6,800 cfs and decreasing.
- At Nimbus Dam on the American River, releases are 1,500 cfs and increasing to 2,000 cfs by November 1 to reach minimum river release flow for the American.
- In the Delta, CVP exports are 2,700 cfs and may increase by November 1 depending on water levels.
- JPP is exporting 1,800 cfs and may increase November 1.
- DCC Gates opened October 11 and will remain open until December 1.
- At Oroville Dam on the Feather River, releases are at 2,150 cfs on Tuesday (10/29) down from 2,250 cfs on Monday (10/28). Releases are slowly decreasing, aiming for 1,750 cfs by November 1 and conserving storage as precipitation is anticipated in the coming weeks.

• SWP exports at Clifton Court this week range between 1,000 to 5,000 cfs, with exports on Tuesday (10/29) around 4,000 cfs. Exports will continue to decrease to the 1,300 to 1,500 cfs range by November 1 as precipitation is anticipated.
