Review Operations Outlook

- At Shasta Dam on the Sacramento River, releases are 6,200 cfs with the possibility of decreasing this week. Folsom is releasing 2,000 cfs and New Melones is between 200 cfs and 500 cfs on the tail end of the Fall Pulse Flow.
- JPP exports are just below 3,500 cfs, having decreased slightly since Monday (11/4) due to unit issues. Repairs are in place to get back up to 3,500 cfs as quickly as possible.
- At Oroville Dam on the Feather River, releases are at 1,750 cfs and holding.
- SWP exports at Clifton Court are 3,200 cfs and will decrease this week to reach the monthly combined Delta outflow requirement of 4,500 cfs; exports will increase again if there's precipitation.
