## Review Operations Outlook

- At Whiskeytown Dam on Clear Creek, releases range from 200 cfs to 650 cfs due to a pulse flow.
- At Shasta Dam on the Sacramento River, releases are 9,000 cfs and will increase to 14,000 cfs tomorrow (5/21) and then ramp down.
- At Nimbus Dam on the American River, releases are steady at 3,500 cfs.
- At Goodwin Dam on the Stanislaus River, releases are 1,300 cfs, with releases ranging between 1,300 cfs to 2,500 cfs from the continuation of a pulse flow.
- At Oroville Dam on the Feather River, releases are 1,700 cfs today (5/20) and will hold for the next few days to allow the reservoir to top off, and then likely increase to hold the lake elevation steady.
- JPP exports are 3,500 cfs today (5/20) and will decrease to 3,200 cfs on Thursday (5/22).

- CCF exports are 600 cfs and will hold until the end of May.
- DCC Gates will open on Friday (5/23) for the Memorial Day weekend and will close on Tuesday (5/27).

#### Additional Questions or Comments

- Question: Will JPP exports be 3,500 cfs for the rest of the week or will exports go back and forth between two and three units?
  - Answer: Exports at JPP are 3,500 cfs today and tomorrow but will likely decrease with Vernalis flow diminishing. JPP is now operating to the CVP's respective share of the OMR -5,000 cfs threshold.

### Review PA Assessment and Assessment Triggers (Reclamation)

*Facilitator's note: Due to the new PA, DMW will only review the Weekly Fish and Water Operations Outlook. Moving forward, Reclamation will potentially produce assessments for relevant salmon and smelt triggers weekly. A review of the PA Assessment may occur if a real-time trigger occurs.*

- Reclamation shared that there has been no steelhead or winter-run loss in the last week. The entrainment risk should be low for the two species through the DCC gates once they open.

#### Additional Questions or Comments

- Question: Did the genetic results confirm if the fish salvaged on 5/11 week was a winter-run?
  - Answer: The fish was a steelhead.
