 - O Clear Creek Technical Team (meets quarterly): December 2021
 - Sacramento River Temperature Task Group (now meeting approximately monthly):
 12/2
 - Upper Sacramento Scheduling Team Flow smoothing (no regular schedule): Held today 11/10
 - o Feather River Operations Group (meets first and third Thursdays): 11/18
 - o American River Group (meets monthly on third Thursdays, and as needed): 11/18
 - o Stanislaus River Watershed Team (meets monthly on third Wednesday): 11/17
 - o Salmonid Monitoring Team (meets weekly on Tuesdays): 11/16
 - o Smelt Monitoring Team (meets weekly on Tuesdays starting in November): 11/16
- Operational Updates
 - O CVP: Lewiston (Trinity River) releases are 300 cfs. Whiskeytown (Clear Creek) releases are 200 cfs. Keswick (Sacramento River) releases are at 3,500 cfs today and will reduce to 3,250 cfs by 11/13. Nimbus (American River) releases are 550 cfs. Goodwin (Stanislaus River) releases are down to 200 cfs, which is the minimum winter flow; Reclamation's Delta pumping was at 5 units until yesterday evening; weeds and debris have reduced pumping to 1 unit; will add capacity as able. Federal share of San Luis Reservoir is 82 TAF.

O SWP: Oroville-Thermalito Complex (Feather River) releases are currently 950 cfs. DWR is exporting 5,000 today and will increase to 5,500 cfs tomorrow through Clifton Court Forebay. State share of San Luis Reservoir is 294 TAF.
