Operational Updates

- O CVP: Lewiston (Trinity River) releases are 300 cfs. Whiskeytown (Clear Creek) releases are 200 cfs. Keswick (Sacramento River) releases are at 3,250 cfs. Nimbus (American River) releases are 550 cfs. Goodwin (Stanislaus River) releases are at 200 cfs; Reclamation's Delta pumping is at 3 units targeting 2,700 cfs; Federal share of San Luis Reservoir is 95 TAF.
- SWP: Oroville-Thermalito Complex (Feather River) releases are currently 950 cfs.
 DWR is exporting 1,000 cfs today and will decrease to 300 cfs tomorrow through Clifton Court Forebay. State share of San Luis Reservoir is 367 TAF.

- Hydrology Update (DWR and Reclamation)

 - O Upcoming 2022 TUCP and Federal ESA compliance: The agencies, especially Federal agencies, discussed Federal ESA compliance for Reclamation's and DWR's proposed 2022 TUCP. Several options were brought up, with mention of some pros and cons of each, including feasibility. There was mention of past TUCP efforts from 2014 and 2015, and how the current proposed TUCP and associated process compares and contrasts. The WOMT members agreed to discuss Federal ESA compliance of the 2022 TUCP within their respective agencies, and report back at the November 24 WOMT meeting.
