• Operational Updates

- O CVP: Lewiston (Trinity River) releases are 300 cfs. Whiskeytown (Clear Creek) releases are 200 cfs. Keswick (Sacramento River) releases are at 3,250 cfs. Nimbus (American River) releases are 550 cfs. Goodwin (Stanislaus River) releases are at 200 cfs; Reclamation's Delta pumping is at 3 units, targeting 2,700 cfs and dropping to 2 units, targeting 1,700 cfs at midnight (11/25). Federal share of San Luis Reservoir is 61 TAF.
- SWP: Oroville-Thermalito Complex (Feather River) releases are currently 950 cfs.
 DWR is exporting 300 cfs through Clifton Court Forebay. State share of San Luis Reservoir is 411 TAF.

- o Reclamation: Reclamation and DWR will provide a hydrology update at the State Water Resources Control Board meeting on December 7 as well as a summary of the 2022 TUCP, under separate agenda items.

- DWR: DWR and Reclamation will submit the 2022 TUCP to the SWRCB on December 1. DWR Director will be issuing the initial SWP water supply allocation on December 1.

- TUCP/TUCO & Drought Updates

The Temporary Urgency Change Petition (TUCP), TUC Order (TUCO), and related documents (including information reported by Reclamation and DWR) are available online at

- O DWR and Reclamation on track to submit the 2022 TUCP to the SWRCB on December 1.
- DWR and Reclamation on track to submit the vegetation report (Report on the Impact of the EDB on HABs and Aquatic Weeds in the Delta) required by the 2021 TUCO to the SWRCB by December 15.
- Hydrology Update (Reclamation)
 - o Nothing in near term forecast.
- Discussion Items
 - o Follow-up on upcoming 2022 TUCP and Federal ESA compliance: Reclamation will be moving forward with a 7 (d) memo. In making the 7 (d) determination, Reclamation will be doing a biological analysis and seeking technical assistance from USFWS and NMFS. The target date for issuing the memo is middle to end of December.
