- Operational Updates
  - CVP: Trinity River releases at 300 cfs. Sacramento River (Keswick) releases are at 3,400 cfs by tomorrow, reducing to 3,250 cfs by Saturday. Clear Creek releases

- are 200 cfs. American River (Nimbus) releases are 1,300 cfs. Stanislaus River (Goodwin) flows are at 200 cfs. Reclamation's Delta pumping is at 2 units targeting 1,800 cfs. Federal share of San Luis Reservoir is 185 TAF.
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 1,800 cfs.
  Exports at Clifton Court are 500 cfs today and expected to hold for next couple of days. State share of San Luis Reservoir is 326 TAF.

There is currently no change proposed, but it is something to watch.
