- Operational Updates
  - CVP: All flows are at minimum. Trinity River releases at 300 cfs. Sacramento River (Keswick) releases are at 3,250 cfs. Clear Creek releases are 200 cfs. American River (Nimbus) releases are 1,300 cfs. Stanislaus River (Goodwin)

flows are at 200 cfs. Reclamation's Delta pumping is at 1 unit targeting 800 cfs. Federal share of San Luis Reservoir is 196 TAF.

• SWP: Feather River (Oroville-Thermalito Complex) releases are at 1,400 cfs decreasing to 1,200 cfs tomorrow. Exports at Clifton Court Forebay are 300 cfs today and expected to hold for next couple of days. State share of San Luis Reservoir is 323 TAF.

  - Steelhead 6-year study 2019 BA committed to an extension of this study, however this season the SWFSC's request for 1,000 steelhead was denied. SWFSC would like better understanding of why the request was denied and what changes may be made to the study so as to secure CDFW approval. CDFW has already elevated internally and will respond with more information.

  - Initial allocation for SWP released last week: 5 percent plus Health and Safety.

- SWRCB:
  - Lifted curtailments in Delta watershed yesterday, and plan to issue a lifting notice for Term 91 today. If hydrological conditions degrade, the Board may reinstate curtailments.
