• Operational Updates

- CVP: Trinity River releases are at 4,000 cfs for winter variability flows, and will transition directly into the spring pulse flow (not yet scheduled). Sacramento River (Keswick) releases are currently at 3,250 cfs. Clear Creek releases are at 200 cfs. American River (Nimbus) releases are at 7,000 cfs. Stanislaus River (Goodwin) releases are at 1,500 cfs and will drop to 300 cfs for two days next week for study purposes (i.e., collection of egg basket). Reclamation's Delta pumping is at 2 units targeting 1,600 cfs to meet direct demands. Federal share of San Luis Reservoir is full at 964 TAF.
- SWP: Feather River (Oroville-Thermalito Complex) releases increased to 10,500 cfs yesterday for a pulse flow in the Feather River Low Flow Channel; beginning today, flows will be redistributed to the Feather River High Flow Channel to begin ramping down from the pulse flow. Clifton Court exports are 3,500 cfs. State share of San Luis Reservoir is full at 1.06 MAF.
- Hydrology Update (DWR and Reclamation)
 - Forecast showing an approximately half-inch precipitation hitting Northern California at the end of the 5-day period.

 - DWR released Bulletin 120 for April 1: Both the Sacramento River and the San Joaquin River are classified as Wet.
 - Beginning April 1 and through May 31, SWP is required to operate to I:E ratio, per COA 8.17 of the SWP Incidental Take Permit. This COA is currently offramped because the three-day average Delta Outflow is greater than 44,500 cfs.
