#### Operational Updates

- CVP: Trinity River releases are at 9,000 for a pulse flow; two more pulses are expected before late May, when it will transition to summer releases. Sacramento River (Keswick) releases are currently at 3,250 cfs, but going to 4,500 cfs on Friday as a test flow in preparation for two pulse flows (next week and in early May). Clear Creek releases are at 200 cfs. American River (Nimbus) releases are at 7,000 cfs. Stanislaus River (Goodwin) releases are increasing from 300 cfs back to 1,500 cfs after reduction for egg basket retrieval. Reclamation's Delta pumping is at 2 units targeting 1,600 cfs to meet direct demands, and may go up temporarily this week due to negative power pricing. Federal share of San Luis Reservoir is full at 963 TAF.
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 15,000 cfs since Saturday, 4/15, and plan to hold while monitoring inflow. Clifton Court exports are 4,500 cfs and limited by real-time demands. State share of San Luis Reservoir is full at 1.06 MAF.
- Hydrology Update (DWR and Reclamation)
  - Fairly dry conditions expected for the next week or two.
