



The CDFG regulations provide angling restrictions that prohibit angling for listed species (e.g., winter- and spring-run Chinook salmon, and steelhead) within inland waters where those species occur. In addition, ocean recreational angling and commercial harvest are regulated by PFMC in cooperation with the FGC. Amendment 12, dated July 31, 1997, of PFMC's Pacific Coast Salmon Plan (PFMC, 1997) provides the following management objectives that specifically address harvest of listed salmon species:
 - Escapements of salmon stocks listed under ESA will meet or exceed NMFS's jeopardy standards of objectives of NMFS's recovery plans
 - In managing mixed-stock salmon fishing, PFMC will establish maximum exploitation rates according to the level that can be sustained by the weakest natural spawning stocks for which specific management objectives have been defined in the Plan and that are consistent with NMFS's jeopardy standards or recovery plans for stocks listed under ESA

The PFMC annually proposes, prepares, and implements salmon harvest management measures to ensure the fishery management objectives protective of listed species are met.

The 4-month gates-in operation of RBDD has been mandated since 1993. Since that time, numerous Chinook salmon cohorts (yearclasses) have been affected by these gate operations. Information obtained prior to and since 1993 indicate that a very large number of some runs of Chinook salmon, steelhead, and green sturgeon are delayed and/or blocked during their attempt to migrate past RBDD. "Studying" the effects of the 8-month gates-out operation will not change the inherent life history timing characteristics of the species that are affected. In addition, continued inaction will not assist in their recovery as required by ESA.
