





State Well ID 12N01E26A001M (Deep Well; Depth = 670 feet)



State Well ID 12N01E26A001M (Shallow Well; Depth = 275 feet) Distance from River Garden Farms: 2.1 miles



State Well ID: 11N01E02D001M (Deep Well, Well Depth: 690 feet)




State Well ID: 11N01E02D003M (Shallow Well, Well Depth: 190 feet) Distance from River Garden Farms: 2.2 miles




