## **General Information**

 The goal of the DWPR program is to address the need to reduce the costs, energy requirements, and environmental impacts of treating impaired and unusable water

 The goal of the Pitch to Pilot funding opportunity is to aid in the development of innovative and disruptive new technologies or processes at the pilot scale level



# **Objectives**

- Treat brackish groundwater in a less energy-intensive way than current processes and technologies
- Manage reverse osmosis/nanofiltration concentrate by reducing cost, energy, and/or environmental impacts

 Improve efficiency of water treatment processes – either by improvements to pretreatment, post-treatment, monitoring, sensors, or other innovative process/technology

# Objectives (cont'd)

 To address costs, energy usage, and/or environmental impacts of seawater desalination, including intakes and/or outfalls

 Reduce the costs, energy requirements, and/or environmental impacts of treating impaired and unusable water to standards necessary for an identified beneficial use



# **Funding**

- Total of up to \$150,000
- 18-month project
- Funds will be available for each agreement to design, construct the pilot unit, install, and test at an already known location with real water OR at a Reclamation research facility
  - Brackish Groundwater National Desalination Research Facility (BGNDRF)
    - Alamogordo, NM
  - Water Quality Improvement Center (WQIC)
    - Yuma, AZ



# **Eligibility and Requirements**

- Eligible Applicants
  - Entrepreneurs/Individuals
  - Institutions of higher education
  - Profit organizations
  - State and local governmental entities
  - Non-profit organizations
  - Federally-funded R&D centers
  - Indian tribal governments and organizations

- Requirements
  - Non-Federal cost share is not required but highly encouraged
  - Application shall be limited to a maximum of 8 pages
  - Evaluation criteria must be addressed
  - Submit by deadline
    - Wednesday June 17, 2020 at 4pm Mountain Daylight Time

- Section E. Application Review Information of the Funding Opportunity Announcement
  - Make sure all criteria is addressed
  - I. Non-Federal cost share
    - This is not required but if non-federal cost share is provided additional points will be provided (Section E.1.9.)



## Review and Selection Process

#### **Initial Screening**

- Met eligibility
- Application moved to Phase I review
- If not met, will be notified

#### Phase I

- Applications are reviewed by committee
- Notification in July 2020 if application moved to Phase II review
- If not selected for Phase II, applicant will be notified

#### Phase II

- In person pitches are scheduled to be held at Reclamation facility\*
- September 2020
- Recommendations for awarding are prepared

\*Phase II might be conducted virtually if needed subject to travel restrictions and developments associated with the COVID-19 pandemic



## **Review and Selection Process**

### Red-Flag Review

- Recommended awards go through Reclamation's red-flag review
- October 2020

#### Pre-Award Clearance and Approval

- Recommended awards go through preaward clearance and final approvals
- October December 2020

#### Awards and Announcements

- Applicants receiving funding will receive notification – January 2020
- Applicants not selected will also receive notification at the same time

- Funding up to \$150,000 for a 18 month study
- Seeking pilot scale projects
