SYBJECT: Proposed Fy 2006/2007 GCD AMP Science Advisor Review and Advisory

Service Program

An Fy 2004 amendment to SA protocol requires an annual report to AMWG at the summer meeting that:

1. Reviews accomplishments of SA review and advisory services programs.

2. Proposes review and advisory services programs for the SAs for the next two years.

Fy 2005 is the second year in which the GCD AMP SAs have had their two year program of reviews and advisory services approved by AMWG. Annual reviews are proposed for the 2005-2010 period due to the expected dynamics in the program and extensive science planning and review required in the GCD AMP program.

The GCD AMP Science Advisor Program has changed significantly from Fy 2004 to Fy 2006. Even though the SA program was established to provide both review and advisory services, it focused only on reviews from Fy 2002-Fy 2005. The SAs and Executive Director presented only at AMWG meetings and did not provide advisor services.

During the period Fy 2005-2007, the SA program is requested by AMWG, GCMRC, and TWG to provide increased formal reviews and broad advisory service support as follows:

- The Executive Director is to engage the SAs more with GCMRC, TWG and GCD AMP Ad Hoc through his office by meetings, conference calls and e-mail advisory service to these groups.
- The SAs and Executive Director have agreed to facilitate and coordinate development of all GCD AMP science planning documents through the period 5/05 to 7/06 and beyond as revision is needed. The assignment includes significant facilitation, coordination and development work by the Executive Director with GCMRC and development of ecosystem science approaches by the SAs.
- The SAs and Executive Director are to complete a comprehensive assessment of GCD AMP over the period FY 2005/Fy 2006.
- The SA program has also agreed to complete its reviews of GCD AMP science planning documents, which average 5-8 per year.
